<p>a) The issue</p> <p>Under section 192 of the Town and Country Planning Act 1990, an applicant can ascertain whether any operations which are to be carried out in, on, over or under land are lawful. This can be done by applying for a certificate of lawfulness.</p> <p>This application is seeking to ascertain that the proposed building operations outlined in the application are lawful (without the need for a formal planning application) by virtue of Schedule 2, Part 1, Class A of The Town and Country Planning (General Permitted Development) (England) Order 2015.</p> <p>b) The Decision</p> <p>The Certificate be issued for the proposed building operations</p>
