## 4. DECLARATIONS OF INTEREST

To receive declarations of Disclosable Pecuniary and Other Interests, in accordance with the Members' Code of Conduct.

#### **Declaring interests at meetings**

If there is any item of business to be discussed at the meeting in which you have a disclosable pecuniary interest or non- pecuniary interest (Other Interests), you must declare the interest appropriately at the start of the meeting or as soon as you become aware that you have an interest.

Arrangements have been made for interests that are declared regularly by members to be appended to the agenda (Page 10). Any interest noted in the Schedule at the back of the agenda papers will be deemed to have been declared and will be minuted as such by the Democratic Services Officer. As a general rule, there will, therefore, be no need for those Members to declare those interests as set out in the schedule.

There are, however, TWO EXCEPTIONS to the general rule:

- 1. When the interest amounts to a Disclosable Pecuniary Interest that is engaged in connection with any item on the agenda and the member feels that the interest is such that they must leave the room. Prior to leaving the room, the member must inform the meeting that they are doing so, to ensure that it is recorded in the minutes.
- 2. Where a dispensation has been granted to vote and/or speak on an item where there is a Disclosable Pecuniary Interest, but it is not referred to in the Schedule (where for example, the dispensation was granted by the Monitoring

Officer immediately prior to the meeting). The existence and nature of the dispensation needs to be recorded in the minutes and will, therefore, have to be disclosed at an appropriate time to the meeting.

Note: Following the adoption of the new Code of Conduct, Members are reminded that they should declare the existence and nature of their personal interests at the commencement of the relevant item (or as soon as the interest becomes apparent). If that interest is a Disclosable Pecuniary or a Deemed Disclosable Pecuniary Interest, the Member must withdraw from the room.

Where a Member has a Disclosable Pecuniary Interest but has received a dispensation from Standards Committee, that Member may vote and/or speak on the matter (as the case may be) and must disclose the existence of the dispensation and any restrictions placed on it at the time the interest is declared.

Where a Member has a Deemed Disclosable Interest as defined in the Code of Conduct, the Member may address the meeting as a member of the public as set out in the Code.

Note: Council Procedure Rules require Members with Disclosable Pecuniary Interests to withdraw from the meeting unless a dispensation allows them to remain to vote and/or speak on the business giving rise to the interest.

Where a Member has a Deemed Disclosable Interest, the Council's Code of Conduct permits public speaking on the item, after which the Member is required by Council Procedure Rules to withdraw from the meeting.

## 1. Purpose of Report

To consider the renaming of Clinic Drive (both the named and unnamed section of the public highway) following two separate requests.

## 2. Recommendations

- 2.1. The Sub-committee reject the requests received; or
- 2.2. The Sub-committee grant approval for officers to investigate, in accordance with the Street Naming and Numbering Policy for each request.
- 2.3. Subject to compliance with the Policy, it be recommended to Cabinet for approval.
- 3. Background
- 3.1. Cabinet approved on the 9<sup>th</sup> March 2022, a revised Street Naming and Numbering Policy.
- 3.2. Two (2) separate requests have been received by the Council to rename Clinic Drive. Both letters are attached to this report (ref Appendix A and Appendix B).
- 3.3. Clinic Drive is located off Coton Road (A444), it is a one-way street situated alongside Riversley Park, providing access to numerous facilities and dwellings including Riversley Park car park, Riversley Park Childrens Centre and The Holy Spirit Catholic Multi Academy (the named section of the public highway). Leading off Clinic Drive is a

unnamed stretch of public highway providing access to Catholic Church and Our Lady & St.Joseph's School.

## 4. Considerations

- 4.1. If recommendation 2.2 is approved, Officers would need to undertake compliance checks against the Policy to establish whether each request complies with the Policy. Due to the timing of the meeting and deadlines for reports, a full and thorough review has not been undertaken therefore additional time is required. Should the requests fail to comply with the Policy, authority shall be provided to the Assistant Director Governance & Democracy and Assistant Director Planning in consultation with the Chair of the Sub-Committee and other relevant Senior Officers, to refine the request(s) accordingly to be suitable and compliant, with a view of issuing a further report to Cabinet for formal approval.
- 4.2. Please also note section 5. Financial Implications.
- 4.3. If item 2.2 of the report is approved, formal consultation shall be required and will be subject to compliance with the Councils Street Naming and Numbering Policy.
- 4.4. A key provision governing the alteration of street names is section 18 of the Public Health Act 1925, although note that this is an 'adoptive' provision and therefore only effective within an area after formal adoption by the authority concerned. (The provision does not, however, extend to Greater London). Under section 18, an authority may by order alter the name of any street or part of a street.
- 4.5. At least one month's notice must be given before making such an order, either by posting at each end of the street or in some conspicuous position on the street. Each notice must provide information about the right of appeal (to the magistrates' court) against the proposed order.
- 4.6. Any affected residents and/or businesses will have costs incurred due to any change, but this will be reviewed if item 2.2 of the report is approved.
- 4.7. Notwithstanding 4.1 to 4.6 of this report, there are proposed changes to the street naming legalisation and procedure which are set out in the Levelling Up and Regeneration Bill. The Bill is currently in its final stages and is currently in the Consideration of Commons amendments stage. Once finalised, it will be issued for Royal Assent. It should therefore be noted that subject to Royal Assent being granted and the implementation date of the new Levelling-up and Regeneration Bill, the Borough Council may be required to formally consult with residents and businesses and approval required in accordance with the procedure outlined in the Bill.

## 5. Financial Implications

- 5.1. There are cost implications in implementing a change of street name, but these are minimal unless an objection is made to the Magistrates' Court. That said, budget provision is to be identified by the Sub-Committee in consultation with the Assistant Director Governance and Democracy and Strategic Director Finance and Governance (to be identified in the Cabinet report) if the Sub-committee agree recommendation 2.2. The identified budget would be included within the Cabinet report if 2.2 of this report is approved.

- 4. He was schooled in the nursery, infants and junior school in Clinic Drive.
- 5. There are no residents in Clinic Drive.


There can no better time for this to happen, as we currently have visiting our Borough "the angel of Knives" with the positive message that this is bringing to our Borough

## 1. Purpose of Report

1.1. To consider arrangements for the renaming of Sherbourne Avenue Park after Lewis Stevens MBE.

## 2. Recommendations

- 2.1. The Sub-committee reject the request; or
- 2.2. The Sub-committee grant approval for consultation to commence with residents of the borough to rename Sherbourne Avenue Park after Lewis Stevens MBE.

## 3. Background

- 3.1. A request has been received to rename Sherbourne Avenue Park after Lewis Stevens MBE. This Sub-committee can decide to reject or consider the request further and proceed to next steps.
- 3.2. Lewis Stevens MBE sadly passed away, aged 86, and was the Member of Parliament for Nuneaton between 1983 and 1992, and was also a former Councillor and Deputy Leader of the old Nuneaton Borough Council and lived close to the park.
- 3.3. The park has been identified as a project for refurbishment and improvement works due to funding received under the UK Shared Prosperity Fund (UKSPF) following the Councils bid in 2022 and the name change would be part of this.

## 4. Body of Report

- 4.1. The subject of this report is to rename Sherbourne Avenue Park (address: Sherbourne Avenue, Nuneaton, CV10 9JH) to Lewis Stevens MBE following a request received by the Council, subject to consultation.
- 4.2. The Council has various powers dealing with its functions in respect of the park but there is no specific statutory power dealing with renaming. However, the Council may rely on the provisions contained within s.111 of the Local Government Act 1972 (incidental to its function) to change the name of Sherbourne Avenue Park. Changing the name of the recreation ground under s.111 of the Local Government Act is an executive function.
- 4.3. It is recommended to undertake a form of public consultation. Any consultation must be adequate and fair having regard to all the circumstances and courts have set out some broad guiding principles on what this means:
  - I. Consultation must be undertaken when proposals are at a formative stage;
  - II. Sufficient reasons must be given to allow for intelligent consideration and response by consultees;
  - III. Adequate time must be given for consideration and response and:
  - IV. Consultation responses must be conscientiously taken into consideration before making the decision.

#### 5. Considerations

- 5.1. It should be noted that the implementation of this request would result in officer resource and time to facilitate the democratic approval process, the consultation process, updating internal and external documentation/databases as well as the process to facilitate and manage the process of change on site. In addition, the committee should note this may create conflicting applications, which would place the Council in a challenging position following a previous scenario.
- 5.2. Some destination parks and public open spaces may also have feature signage/noticeboards/memorial street furniture that the decision may have an impact on.
- 5.3. Further to 5.1 and 5.2 above, it should also be noted that the process to undertake such change, if approved and subject to the outcome of the consultation, will incur cost to the local authority such as a potential need for new signage, noticeboards and/or street furniture.

## 1. Purpose of Report

1.1. To outline the procedure for the appointment of Honorary Freemen/Freewomen and Honorary Aldermen/Alderwomen by the Council.

## 2. Recommendations

- 2.1. The contents of the report be noted; and
- 2.2. Potential nominations for Freemen/Freewomen of the Borough or Honorary Alderman/Alderwoman to be submitted to the Civic Honours Sub-Committee, which will be considered at the meeting or future meeting and if approved the Head of Paid Service be requested to refer the recommendation to an Extraordinary Full Council to be called for the purpose of voting upon the nomination(s).

## 3. Background

- 3.1. In accordance with regulation 249 of the Local Government Act 1972, a principal council may, confer the title of Honorary Aldermen (or Alderwomen) on persons who have, in the opinion of the Council, rendered eminent services to the Council as past members of that Council, but who are not then Councillors of the Council.
- 3.2. As for Honorary Freemen/Freewomen, this was passed under the Honorary Freedom of Boroughs Act, 1885, (now replaced by the Local Government Act of 1972). The current powers allow the Council to admit Honorary Freemen/Freewomen of the Borough of persons of distinction, and persons who have, in the opinion of the Council, rendered eminent services to the Borough.

- 3.3. It should be noted that:
- 3.3.1. A budget will need to be identified and confirmed if the recommendation is agreed by this Sub-committee when seeking a decision from Council; and
- 3.3.2. No Honorary Alderman/Alderwomen shall, while serving as a Councillor of the Council, be entitled to be addressed as Alderman/Alderwomen or to attend or take part in any civic ceremonies of the Council as an Alderman/Alderwomen; and
- 3.3.3. An Honorary Alderman/Alderwoman of a principal council may attend and take part in such civic ceremonies as the council may from time to time decide, but shall not, as such, have the right—
  - (a) to attend meetings of the council or a committee of the council (including a joint committee upon which they are represented); or
  - (b) to receive any such allowances or other payments as are payable under sections 173 to 176 of the Local Government Act 1972.

## 4. Appointment Process

- 4.1. Honorary Aldermen/Alderwomen
- 4.1.1. To appoint an Honorary Alderman/Alderwoman, the Council has to, by a resolution passed by not less than two-thirds of the members voting thereon at a meeting of the Council, confer the title of Honorary Alderman/Alderwoman.
- 4.1.2. In accordance with 3.1 of the report, any nomination must be a person who rendered eminent services to the Council as a past member of the Council, but who are not then a member of the council.
- 4.2. Honorary Freemen/Freewomen
- 4.2.1. To appoint Honorary Freemen/Freewoman, the Council has to, by a resolution passed by not less than two-thirds of the members voting thereon at a meeting of the Council, confer the title of Honorary Freemen/Freewoman to persons of distinction, and persons who have, in the opinion of the authority, rendered eminent services to that place or area.

## 4.3. General

4.3.1. The Sub-committee is required to identify suitable persons for both honours and establish that the honour will be accepted. Once agreeable in principle, in accordance with regulation 249 of the Local Government Act 1972, the calling of a Council meeting is required to make the appointment formally.

- 4.3.2. To ensure a formal appointment process made by a resolution, approval by not less than two-thirds of the members voting thereon at a meeting of the Council, confer the title of Honorary Aldermen/Alderwomen on persons who have, in the opinion of the Council, rendered eminent services in accordance with 3.1 and/or 3.2 of this report.
- 4.3.3. To trigger 4.3.2 above, the Sub-committee will need to move a recommendation which effectively triggers the process. A suggested form of words for this could be:
  - "1. That .... be admitted as an honorary alderman/freeman (or alderwoman/freewoman) of the Nuneaton and Bedworth Borough Council under Section 249 of the Local Government Act 1972 in recognition of [the eminent services which s/he has rendered to ...] [his/her distinguished ...] [and that his/her name be enrolled on the freemen's/freewomen's roll]
  - 2. That the common seal of the Council be affixed to the [enrolment of ... on the said freemen's roll and to the certificate to be presented to him/her on his/her admission as an honorary freeman/freewoman of the Borough] [certificate conferring upon ... the title of honorary alderman/alderwoman].
  - 3. That an estimated expenditure of £... be approved for the purposes associated with the appointment and that the Chief Executive be authorised to agree any consequential matters."

Building a Better Borough Priority: We want to make our borough a place where our residents enjoy living and in which others choose to make their home.

## 1. Purpose of Report

This report updates the sub-committee on the process which members of the public will need to follow in order to nominate others for a civic award from Nuneaton and Bedworth Borough Council.

## 2. Recommendations

The sub-committee endorses the proposals and approach adopted in section 4 of this report.

## 3. Background

The sub-committee has previously discussed principles of a scheme which would allow members of the public to nominate fellow citizens for a civic award from Nuneaton and Bedworth Borough Council.

These principles include: a seconder is required for every nomination, people may not nominate themselves, and all nominations are to be validated before consideration by this sub-committee.

## 4. Body of Report

To help make it easier for members of the public to make a nomination for an award, a web form has been established and tested ready for use.

Members of the public will need to complete the form to supply information to start the process, including full details of the:

Person proposing the nominee

- Seconder for the nominee
- Nominee
- Reason for nomination

They are also able to indicate which award for which they wish the person to be considered.

Although the web form is the preferred means by which people will be invited to make nominations, a paper copy of the form will be available on request from customer services.

Nominees will be contacted prior to submission to the Civic Honours Sub-Committee to ensure that they are happy to be nominated and considered for an award.

All validated nominations will be considered by the Sub-Committee. The final decision on recommendations brought will be taken by Cabinet and ratified at Full Council.

Presentations to deserving nominations will take place towards the end of the Mayoral Year, each April.

This process is open to all members of the public. The following nominations will be accepted:

- Award of Merit
- Naming of places or streets in the Borough
- Honorary Aldermen or Alderwomen
- Mayor's Award
- Freedom of the Borough
- Freedom of Entry to the Borough

Stakeholders will also be invited to submit nominations at the opening of the nominations window each November. The Civic Honours page on which the form will be published can be found here.

## 5. Conclusion

The process set out above describes how members of the public may make nominations for civic awards is now ready to be published so that citizens may nominate individuals for awards using a simple online form.
