RECORD OF THE DECISION

a) The issue

NBBC has been without a corporate intranet for a number of years and communication has been conducted using emails and other less effective tools. The Sharepoint platform forms part of NBBC's Microsoft estate and can be utilised with no additional on-going hosting or licensing costs.

b) The Decision

In order to facilitate more effective communication and increased engagement, a decision has been taken to appoint a third party supplier to assist in the implementation of Sharepoint as our corporate Intranet and to deliver a low level design to migrate network shares into the environment.

REASON FOR THE DECISION

Provision of a corporate Intranet will increase the efficiency of internal communication and engagement. Migration of network shares to Sharepoint will reduce the current costs associated with file storage.
