RECORD OF THE DECISION

a) The issue

On 9 January 2023 the appellants submitted an application for planning permission for a development of circa 700 dwellings on land to the West of Weddington Road, forming part of Canal Farm. Before the matter could be determined by the Council, the appellants appealed on the grounds of non-determination. That appeal came before an inspector appointed by the Secretary of State for Levelling-up Housing & Communities.

As part of the Inquiry process it is usual for the Local Planning Authority to agree the necessary terms of a planning obligation to cater for the eventuality that planning permission is granted on appeal. A similar position arises in connection with the imposition of conditions.

A number of obligations, broadly reflecting those reported to the Planning Applications Committee on 21st November 2023, after the appeal had been lodged, have been negotiated by officers of the Council, County Council & Integrated Care Board providing for:

Affordable Housing;
Biodiversity Net Gain provision;
Education – including a new Primary School onsite;
Electric Car Charging;
Health contributions to expand local facilities serving the locality;
Open Space provision;
Sport & Leisure Provision; &
Transport contributions.

b) The Decision

The Planning obligation as outlined above be approved.

REASON FOR THE DECISION

To comply with the requirements of Government guidance and to ensure that suitable contributions are received to offset the impact of the development in the event that permission is granted.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

None. To not agree the terms of an obligation would be contrary to government guidance and could lead to a claim for costs on the basis that the Council has acted unreasonably.
