**Subject:** Appointment of Independent Persons

### 1. Purpose of Report

1.1 To confirm the arrangements for the appointment of Independent Persons as required by Section 28 of the Localism Act 2011 for a four year term of office.

#### 2. Recommendation

2.1 That the arrangements for the appointment of Independent Persons for a four year term of office be approved.

### 3. Background

- 3.1 Part 1, Chapter 7 of the Localism Act 2011 came into effect on 1 July 2011 (the Act). Section 28 of the Act requires the Council to appoint at least one Independent Person whose views will be sought when making decisions about allegations that Councillors have breached the Code of Conduct.
- 3.2 The Act requires that any Independent Person must not be, or have been within the past 5 years, a member, co-opted member or officer of the Council or any of the Parish or Town Councils in the Councils' area; nor should they be a relative or close friend of a member, co-opted member or officer in the Councils' area. Following a joint appointment process in 2012, involving public advertisement and interviews this Council confirmed the appointment of a pool of 10 Independent Persons in July 2013.
- 3.3 The role of the Independent Person was widened under the Local Authorities (Standing Orders) England (Amendment) Regulations 2015 which came into force on 11 May 2015 and changed the localised disciplinary process. A panel of at least 2 Independent Persons has to be convened to make recommendations to Council in connection with statutory Chief Officers.
- 3.4 The panel was last refreshed in 2017 and the current 4 year term is due to expire. As before, arrangements are in hand, with the County Council; Solihull Metropolitan District Council and Rugby Borough Council to refresh the pool. Warwickshire County Council has agreed to take the lead in connection with this and will be managing the advert and recruitment process.

## 3.5 Financial Implications

There are no direct costs incurred in the appointment and training / development of Independent Persons because they do not receive an allowance and training will be delivered jointly by the Monitoring Officers of the participating authorities. Independent Persons are, however, entitled to receive up to £30.83 per half day to cover expenses for attending Subcommittee meetings of the Audit & Standards Committee. This sum was recommended by the Independent Remuneration Panel in 2017.
