Cabinet Report to Council, 16th September 2020

1. <u>Introduction</u>

This report deals with the Cabinet meeting held on 22nd July and 9th September 2020.

It also includes details of any reports from the West Midlands Combined Authority Board, which have, or may have in the future, a direct impact on NBBC, namely the Board meeting of 24th July

2. 9th September, 2020 Cabinet Meeting

a) <u>General Fund and Housing Revenue Account Quarterly Budget Monitoring</u> <u>Q1 2020/21</u>

Finance and Civic Affairs – Councillor J.A. Jackson (Key Decision)

The Executive Director – Resources submitted a report to Cabinet detailing the budget position from the first quarter. The report showed the financial impact of the pandemic on the Council's budget and that whilst government funding has contributed towards closing the in-year gap, there is still a shortfall. The gap will therefore need to be funded by in year savings, deferrals to the Capital Programme and reserve contributions. The additional reserve contributions are just to cover the unexpected impact during 2020/21 and any longer-term impact of COVID-19 will need to be considered when setting the budget for 2021/2022.

b) Statement of Community Involvement (SCI) - Adoption

Planning Development and Health – Councillor Neil Phillips (Key Decision)

The Director – Democracy, Planning and Public Protection submitted a report to Cabinet to then be submitted for Council approval. The report detailed the changes that had been made to the Statement of Community Involvement (SCI) due to government guidance in light of the current pandemic. The SCI in its current form could not be complied with whilst also maintaining the guidance on combating the spread of the Coronavirus. The update therefore included the use of online methods to their full potential. In normal circumstances any change to the SCI would require consultation however due to the pandemic and the guidance set out in the SCI this is not currently possible. It should be noted that these changes are temporary whilst the restrictions to COVID-19 take place.

c) <u>Draft Nuneaton and Bedworth Borough Community Infrastructure Levy</u> **Charging Schedule**

Planning Development and Health – Councillor Neil Phillips (Key Decision)

A report was submitted from Director – Democracy, Planning and Public Protection detailing the benefits and regulatory processes for having a CIL. Cabinet approved the request to go out to consultation prior to its submission for independent examination as once in place the CIL will maximise the potential for new development to generate income for the delivery of new infrastructure whilst also ensuring that proposed rates do not render new development in the Borough financially unviable.

d) Local Development Scheme

Planning, Development and Health – Councillor Neil Phillips (Key Decision)

Cabinet approved the Local Development Scheme (LDS) which had been prepared in order to identify current planning policy documents that are being applied in Nuneaton and Bedworth and to provide a three year project plan that outlines what the replacement planning policy documents will be and their stages of preparation. This is being submitted for Council approval.

e) NBBC – Leisure Procurement Strategy

Arts and Leisure Portfolio – Councillor Ian Lloyd (Key Decision)

Cabinet approved a report submitted by Director – Leisure, Recreation and Health that detailed a Leisure Procurement Strategy for Nuneaton and Bedworth which would support its future development and delivery of leisure facilities working with Sports England, its Project Management and Design & Cost Consultants and partners. This is a positive step which will hopefully see real change to our Leisure facilities.

3. West Midlands Combined Authority (WMCA)

The WMCA Board meeting on the 24th July included a report on Economic Recovery in the West Midlands, focusing on the impact of the COVID-19 pandemic and the WMCA's response so far. This included a 'State of the Region' update, analysing the region's economic performance and how this has been impacted by COVID. A progress update on the WMCA's Regional Recovery Plan and a summary of the 'Recharge the West Midlands' case to government was also included in the report.

The Board also received a Financial Monitoring report as at the end of May 2020 which showed that the WMCA, as with other local authorities in the region, is experiencing significant income reductions due to the COVID-19 pandemic and this is putting pressure on the short and medium term financial position.
