RECORD OF THE DECISION

The issue

NBBC has used Microsoft products as part of our core infrastructure and security, and to provide office and telephony functionality for the business for a number of years. The current licensing agreement is due to expire at the end of June 2024 and a new licence agreement needs to be entered into and a contract awarded.

b) The Decision

In order to continue the use of the Microsoft suite of products, a decision has been taken to procure the required licences and enter into a further three-year agreement via a Crown Commercial Service (CCS) Aggregation exercise.

REASON FOR THE DECISION

Microsoft licences are required in order to provide support and maintenance of our infrastructure and to provide access to essential operational functionality.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

We could choose to award the contract via an alternative procurement route. Utilising the CCS Aggregation opportunity provides access to additional potential discounted pricing.

We could choose to move away from Microsoft as our core platform. This would be a huge undertaking, as our core infrastructure and the majority of tools across our environment are Microsoft products.
