Delivered by Coventry City Council

Garden and food waste - 1 x 240 Litre (£40 + bin)



- Additional general waste capacity for larger families (6 or more in a household)
- Additional recycling bins available on request
- Assisted collections on request
- Clinical collections on request



- Bulky waste collections £32 for the first item, every subsequent item is an additional £3.50
- Replacement and new bin charges



Types of contamination


Breakdown average percentage of contamination - September 2023 to April 2024




Recycling complaints April 2024



In 23/24 average of 63 complaints were received per month from 290,000 wheelie bin collections <u>0.0002 complaints per collection</u>



Nuneaton and Bedworth recycling performance



Summary of work


- Monthly litter picks and road sweeping of streets
- Nuneaton and Bedworth Town Centres receiving a daily litter pick
- 430 litter bins, visited weekly
- A444 has received 3 daytime picks and 4 nighttime picks
- Our road sweepers have collected 834.14 tonnes of road sweepings



Fly tipping report and enforcement


We have our own in-house enforcement team, support by our Contractor District Enforcement

Environmental Bill 2021

- Will require the collection at the kerbside of six recyclable waste streams (plastic, paper and card, glass, metal, food waste and garden waste, the latter only where requested)
- The Council is working to understand the impact of these mandatory requirements, along with its Partners, however no decisions have been made and there are no proposed changes to how household waste is collected in the Borough
- We will have to put in place a weekly food waste collection service by 1st April 2026
- Working with WRAP (Waste and Resources Action Programme) to understand the resources needed
- New burden funding is being made available from DEFRA to support the implementation of food waste. (final details yet to be received)
