To provide an update to Cabinet on the Green Bin service and asks it to note that the subscription fee for the service will be reviewed as part of the Council's annual review of its fees and charges.

Recommendations:

- a) A review of the green bin charges will take place as part of the Council's annual process of reviewing its fees and charges.
- b) To ensure the service is meeting the needs and expectations of residents, a full review of the service, including a public consultation will take place in June and July 2025. This review will also examine the impact of the mandatory requirements on food waste collections.
- c) That the Environment and Leisure Overview and Scrutiny Panel working with the portfolio holder undertake a food waste review

Reasons:

The price of the Service has remained unchanged since its introduction in 2018 and has never been reviewed. The Environment Bill 2001 will require the Council, as a waste collection authority, to collect food waste through a separate weekly collection. The Green Bin will no longer be able to accept food waste once a weekly food waste collection service is implemented.

1. <u>Purpose of Report</u>

- 1.1 This report update's Cabinet on the Green Bin service and ask's it to note that the subscription fee for the service will be reviewed as part of the Council's annual review of its fees and charges.
- 2. <u>Recommendations</u>
- 2.1 That Cabinet note the following :
 - a) A review of the green bin charges will take place as part of the Council's annual process of reviewing all its fees and charges.
 - b) To ensure the service is meeting the needs and expectations of residents, a full review of the service, including a public consultation will take place in June and July 2025. This review will also examine the impact of the mandatory requirements on food waste collections.
 - c) The portfolio holder will be undertaking a review of the impact of food waste collections for the Borough, working with the Environment and Leisure Overview and Scrutiny Panel.
- 3. <u>Background</u>
- 3.1 The garden and food waste collection service is a discretionary service that collects approximately 8,000 tonnes of compostable material a year from 24,888 households.
- 3.2 Since 2018 the subscription has been set a £40 per bin and has remained unchanged since its introduction. There are no discounts.

- 3.3 The service operates from February and ends the following mid-January, providing 25 collections.
- 3.4 Once collected, the material is passed to Warwickshire County Council who are the designated waste disposal authority, who are responsible for its disposal.
- 3.5 The Environment Bill 2001 will require the Council, as a waste collection authority, to collect food waste through a separate weekly collection. This service has to be free and is detailed to commence from April 2026.

4. Conclusion

- 4.1 The Council hasn't reviewed the service since its introduction in 2018, operating unchanged since that time.
- 4.2 Due to the new requirements which will require the Council to collect food waste on a weekly basis for free, it is appropriate to review the whole service, as due to the upcoming changes food waste will no longer be able to be collected through the green bin.
