RECORD OF THE DECISION	

a) The issue

Providing access (via a User Agreement) to the Efficiency East Midlands Ltd (EEM) public sector framework agreements, for Nuneaton and Bedworth Borough Council to consider and utilise (should it choose to do so) to undertake procurements for the provision of goods, services and works.

b) The Decision

Sign a User Agreement to enable to the Council to consider and utilise (should it choose to do so) the public sector framework agreements as a route to market for the provision of goods, services and works.

REASON FOR THE DECISION

It provides a procurement route to market to procure, if deemed best value, to undertake procurements for the provision of goods, services and works to allow the Council to undertake its day-to-day operations.

Signing the User Agreement allows the Council to utilise the Framework Agreement available which supports the principles of value for money, the Procurement and Accounts Payable Strategy and will ensure the Council achieves best value through the procurement process. The Council will only use this as a route to market if it deems it best value to do so. Alternatively, the Council would utilise an alternative framework agreement or undertake its own competitive tender process.

EEM is a not-for-profit procurement consortium offering cost and efficiency savings for the public sector across England and Wales. EEM's priority is to support all members in their common goal – to provide efficiently delivered and high quality products and services to the communities they serve. EEM is a framework which typically has a lower rebate due to their not for profit setup (EEM takes a small commission directly from suppliers; a maximum of 1.5% for service frameworks and 1% for materials) and over the last few years, EEM has generated a surplus which is provided back to members for social value purposes. As a not-for-profit organisation they ensure their surplus is reinvested into communities through their Community Donation scheme which distributes thousands of pounds to our members each year. Since 2014 over £2 million has been donated through this scheme. Since the Council has used the framework agreement, the Council has received a donation payment which has then been donated to the Mayors Charity. This is a unique feature of EEM and one that highlights their strategic aim which is to support communities and obtain value for money for public sector bodies.

For the avoidance of any doubt, the above information regarding the rebates and community donation scheme is available on their website so is not considered commercially sensitive information.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

Not signing the User Agreement

If the Council does not sign the User Agreement, it will not have the option to access or consider the public sector framework agreements EEM procured on a national basis for and on behalf of public sector bodies. Whilst there are framework agreements available (as well as the option to undertake our own Tender), having access to a wide variety of public sector procurement routes allows the Council to select an effective and best value procurement strategy for a given requirement.

It is worth stressing, the Council is not obligated to utilise any Framework Agreement in EEM's portfolio upon signing the User Agreement, but it provides the option for the Council to do so. The Council is not required to pay to sign the User Agreement as EEM recoup their costs via the call-off contracts entered into between the Council and the successful supplier/contractor.
